1 Students who have met all graduation requirements on the day of graduation and students who are within  
2 two (2) or fewer credits of meeting all requirements<sup>1</sup> and can complete the requirements during the  
3 summer may participate in graduation activities. If extenuating circumstances exists at any school, the  
4 matter shall be presented to the board prior to graduation activities.

5  
6 Students are expected to participate in all graduation activities, and graduation apparel shall be  
7 determined by the administration of each school and shall be the personal expense of each student. Any  
8 fees required for graduation ceremonies may be waived for students who are eligible to receive free or  
9 reduced price lunches, and in such cases, the school shall assume responsibility for payment of fees.<sup>2</sup>

10  
11 Graduation ceremonies shall be physically accessible to all students, their parent(s)/guardian(s), and  
12 other interested citizens.<sup>3</sup>

13  
14 Students who do not wish to participate in graduation activities shall notify the school principal in  
15 writing at least five (5) days prior to the day of graduation. Non-participating students shall receive their  
16 diploma certificates from the principal's office within one (1) week of the day of graduation.

17  
18 The ceremony and all activities included shall not be religious in nature.<sup>4</sup> The content of any students'  
19 speeches shall not reflect the endorsement, sponsorship, position, or expression of the school, employees,  
20 or the board.

21  
22 The director of schools shall develop procedures to ensure that students are recognized at graduation  
23 ceremonies for the following achievements:<sup>5</sup>

- 26 ● Honors;
  - 27 ● State Honors;
  - 28 ● State Distinction;
  - 29 ● District Distinction;
  - 30 ● Tri-Star Scholar;
  - 31 ● Students receiving a TN Seal of Biliteracy;
  - 32 ● Students voluntarily completing at least ten (10) hours of community service each semester the  
33 student is in attendance at a public high school;
  - 34 ● Students receiving a gold or platinum medal on National Career Readiness Certificate; and
  - 35 ● Students graduating with a district-developed work ethic distinction.

36 The Dyer County Board of Education may not allow students to apply to take the General Equivalency  
37 Diploma test before four school years from their initial high school enrollment date has elapsed or are  
38 age appropriate.
